Scope and Purpose

The Indian Ocean is a vast sea linking a diversity of societies to its west, north, and south. These stretch from Australia, to Southeast Asia, to the Indian Subcontinent, to Persia and the Arabian Peninsula, to the east African coast. This course is an introduction to the history of the peoples and societies of these areas from the earliest recorded times to the present. Emphasis is on the western part of the Indian Ocean, especially India, Arabia, and east Africa. The Indian Ocean is unique in its history of intensive indigenous shipping and commerce before the arrival of Europeans (1498), and in the coexistence of European and indigenous trade during the modern era. A region of tremendous importance globally, the Indian Ocean has been neglected as a unit of historical inquiry. This is especially strange since the Indian Ocean, together with the Mediterranean, delimits the classical Islamic world of the seventh through fifteenth centuries. In this class we will be particularly interested in transformations in Indian Ocean economies and in the movement of people about the Ocean into modern times.

- 4. Map Quiz. Soon after the spring break you will be expected to correctly identify places, towns, bodies of water and other features on a map of the Indian Ocean. What you must know is listed below in the syllabus.
- 5. A project. The project will be a 15-20 page paper based upon your reading of an assigned set of material on some thematic dimension of Indian Ocean History.
- 6. A final examination. The final examination will be based on the assigned reading and course discussions. It will consist of a take-home examination in which you will answer questions with essays, well argued and structured.
